"In our opinion, these financial statements present fairly, in all material respects, the financial position of the Society as at August 31, 2005 and the results of its operations and cash flows for the year then ended in accordance with Canadian generally accepted accounting principles."

KCCS has investments over \$1 million. Net Income was \$125,000 (\$66,000 in 2004). Details of revenue can be found in the Schedules.
